



# REGULATIONS

## BCC Fun Fest Block Party

The Fun Fest Block Party is a family-oriented event designed to bring together BCC students, staff, faculty and other county residents for a variety of educational, cultural and recreational activities. The Fun Fest Block Party has evolved into a much-anticipated event for people throughout Burlington County, and it receives extensive advance publicity from the local media. The Fun Fest Block Party attracts thousands each year. It is within this context that the College and its Fun Fest Block Party Committee will strictly enforce the following regulations:

1. All exhibits must be in good taste. Pornographic or obscene items are absolutely unacceptable and will not be permitted. The Fun Fest Block Party committee reserves the right to order unacceptable items removed from the exhibitor area.
2. Craft exhibits are limited to vendors whose materials are either made by themselves, their clientele, or recognized craftspeople. Vendors of factory manufactured clothing (sneakers, jewelry, jackets, handbags, etc.) will not be permitted. Other commercial items may be deemed unacceptable by the Fun Fest Block Party Committee. If you are not certain if your items are acceptable, please call ext. 1332 at (609) 894-9311 or (856) 222-9311.
3. No food items may be sold unless approved in writing at least four weeks in advance by the Fun Fest Block Party committee. If you are interested in selling food items you must submit the food vendor registration form (note: recognized Burlington County College student organizations need not submit this form, but should submit their request via student services channels).
4. **No crafter/vendor will be granted exclusive rights to sell particular products or services at the Fun Fest Block Party.**
5. **ALL VENDORS/EXHIBITORS MUST HAVE THEIR DISPLAYS IN PLACE AND OPERATIONAL NO LATER THAN 11:30 AM ON SATURDAY, APRIL 30, 2011, OR ON THE RAIN DATE OF SUNDAY, MAY 1, 2011. *Anyone arriving after that time will not be permitted to exhibit. Set up may begin after 9 AM.*** All vehicles must be removed from the exhibit area by 11:30 AM. The road will be closed off to all traffic beginning at 11:30 AM and will not be opened until 4:00 PM. **NO EXHIBITS MAY BE BROKEN DOWN UNTIL 4 PM.** A confirming letter will be sent to approved vendors/exhibitors with specific set up instructions. Please note: Parking adjacent to the exhibit area is extremely limited and parking regulations will be enforced.
6. All exhibits will be outdoors.
